## **BATTERY INSTALLATION & MAINTANENCE**

1. Your candles requires two (2) D batteries (sold separately).
2. Turn candle over and remove cover from the battery compartment.
3. Insert two D batteries as illustrated in the battery compartment.
4. Replace battery compartment cover.

LOW BATTERY INDICATOR – Your Luminara™ candle will begin flashing/blinking when the batteries are too weak to properly power the candle. If your candle begins flashing/blinking, replace the batteries.

Remove batteries once they have run out of power or if the product has been left unused for an extended period of time.

## **OPERATION**

ON/OFF:

To turn the candle on, slide the power switch on the bottom of the candle to the “ON” position.

To turn the candle off, slide the power switch on the bottom of the candle to the “OFF” position.

TIMER:

To set the timer, slide the power switch on the bottom of the candle to the “TIMER” position. The candle will remain on for five (5) hours from the time that you place the candle in “TIMER” mode. After five (5) hours of run time the candle will automatically turn off for nineteen (19) hours. It will repeat the same cycle daily until the user resets the timer. To reset the timer, slide the power switch to the “OFF” position and then to “TIMER” at the desired start time.

## **LIMITED WARRANTY**

Your Luminara™ candle is guaranteed to be free from manufacturing defects for a period of ninety (90) days from the date of purchase. This warranty does not cover damage due to neglect, misuse, exposure to excessive heat or improper battery installation. Please return your product to the place of purchase with the original sales receipt for repair or replacement if repair is not possible. You may also contact us by e-mail at [mail@myluminara.com](mailto:mail@myluminara.com) for warranty information. Proof of purchase is required.

## MAINTENANCE

Clean as needed with a soft, dry cloth. If needed, use a damp cloth with a mild household soap. Note that the color may vary from candle to candle, and the color and scent (if included) may fade over time.

## CAUTION

- ◆ Your Luminara™ candle is made of real wax and is flammable. Do not attempt to light this candle. Doing so could result in personal injury or damage to the light and electrical components.
- ◆ The Luminara™ wax candles are intended for indoor use. Keep out of direct sunlight, away from heat sources and out of extreme temperatures or you Luminara™ candle may soften or melt. Doing so may result in damage to the components or the wax shell and will void the warranty.
- ◆ The Luminara™ plastic “outdoor” candle is made to withstand outdoor use.
- ◆ Place the candle on a protective base, on a candle stand, or in a lantern to protect furniture from wax deposits.
- ◆ Your Luminara™ candle is breakable. Dropping it can break or damage the wax shell and can also damage internal components, and will void the warranty.
- ◆ This product contains small parts, which, if removed, can pose a choking hazard. Keep away from small children.
- ◆ Insert batteries as displayed on the battery compartment. Failure to insert the batteries correctly may result in damage to your candle or personal injury and will void the warranty.
- ◆ Do not mix old and new batteries. Do not mix Alkaline, Carbon-Zinc, NiMH, or NiCad batteries. Please recycle used batteries or dispose them safely in accordance with the battery manufacturer’s recommendations.
- ◆ Always purchase the correct size and grade battery most suitable for the intended use.
- ◆ Replace all batteries of a set at the same time.
- ◆ Clean the battery contacts and also those of the device prior to battery installations.
- ◆ Ensure the batteries are installed correctly with regard to polarity (+ and -)
- ◆ Remove batteries from equipment which is not to be used for an extended period of time.
- ◆ Remove used batteries promptly.

## **FCC COMPLIANCE**
